

CIRCULAR -03/2014

Sub: E-Freight Initiative at CSI Airport, Air Cargo Complexreg

Attention is invited to all concerned operating at Air Cargo Complex, CSI Airport. As E-Freight initiative, MIAL is in the process of introducing the below activities as the first phase of operation with effect from 12th March 2014.

- 1. Elimination of Airway Bill copy at the time of TDG Cargo acceptance in the Truck Dock Gate. It will be mandatory to enter the dimensions while creating the on-line TSP.
- Implementation of GMAX GVK MIAL AIR XCHANGE the first Air Cargo Community Portal of India. With effect from 12th March 2014 onwards for effecting MIAL on-line transactions, users need to access the URL – www.gmax.gvk.com instead of http://cargo.gvk.com. As the current web portal URL - http://cargo.gvk.com will not be operational from 12th March 2014 onwards.
- 3. Implementation of 100% import bank challan through on-line by Importers / Consolidators / Customs brokers with effect from 1st May 2014. KIOSK Center and helpdesk is available at Air Cargo Complex for support. BC can be created in PD mode / Bank mode through online for all import transactions. If Bank Mode then one paid copy needs to be submitted for record payment in the system at the counter for further necessary action.

Your login credentials will remain the same but you will be mandatorily required to change your password to ensure adherence to the enhanced security policy. User ID's which are less than 6 characters will also need to be updated as per the enhanced security policy.

Kindly note there is no change in any of the process and procedure for executing on-line cargo operations.
